WHEREAS, recognition u/s14(3)(a) of NCTE Act, 1993 was granted to the institution namely, OM College of Education, No. 51, Nemili, A.P. Nagar, Sriperumbudur, Kanchipuram District-602105, Tamilnadu vide Order No. SRO/NCTE/SRCAPP14213/M.Ed./TN/2017-18/93125 dated 02.05.2017 for conducting M.Ed. Programme of Two years duration with an annual intake of (one unit) of 50 students from the academic session 2017-2018.

- 2. AND WHEREAS, the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause was issued to the institution on 09.07.2024. The institution submitted its reply on 03.08.2024.
- 3. AND WHEREAS, the SRC in its 441st meeting held on 04th August, 2024 considered the matter and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution OM College of Education, No. 51, Nemili, A.P. Nagar, Sriperumbudur, Kanchipuram District-602105, Tamilnadu for M.Ed. programme 1 basic unit of 50 students."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., OM College of Education, No. 51, Nemili, A.P. Nagar, Sriperumbudur, Kanchipuram District-602105, Tamilnadu for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
